

ManpowerGroup Inc.'s Annual Meeting of Shareholders will be held on Friday, May 6, 2022, 9:00 a.m. Central time, virtually via the internet at www.meetnow.global/MXN79FA.

Proposals to be voted on at the meeting are listed below along with the Board of Directors' recommendations.

The Board of Directors recommend a vote **FOR** Proposals 1, 2 and 3:

- 1. Elect twelve individuals nominated by the Board of Directors of ManpowerGroup Inc. to serve until 2023 as directors.
- 2. Ratification of Deloitte & Touche LLP as our independent auditors for 2022.
- 3. Advisory vote to approve the compensation of our named executive officers.
- 4. In their discretion, the Proxies are authorized to vote upon such other business as may properly come before the meeting.
